Owned by the Saskatchewan Catholic Health Corporation and supported through a partnership with Saskatoon Health Region (SHR), St. Paul's Hospital provides expertise and leadership in the health region in Renal (Kidney) Services, Emergency Services, Palliative Care Services, Medical Imaging and Nuclear Medicine, Spiritual and Cultural Care, Chronic Disease Management, Mental Health and Addictions, Laboratory Medicine, Saskatchewan Transplant Program and Ethics Services. The Leslie and Irene Dubé Urology Centre of Health is also located at St. Paul's Hospital.

#### **Healing Through the Arts**

The Program, run in collaboration with Volunteer Workforce Services, is funded by St. Paul's Hospital Foundation. Patients are referred to the Healing Arts Program by doctors, nurses and other health care staff. Patient artwork galleries, poetry readings and concerts are often organized to extend the benefits of Healing Arts to everyone in the Hospital.

## Managed Program Area Highlights

#### St. Paul's Hospital Managed Programs

St. Paul's Hospital offers a comprehensive range of services to people living in Saskatoon and Saskatchewan. In addition, St. Paul's Hospital manages the following programs on behalf of and throughout Saskatoon Health Region:

#### **Spiritual Care**

Spiritual Care has always been an integral aspect of patient care at St. Paul's Hospital. Rooted in the spirit of Saint Marguerite d'Youville who founded the Grey Nuns in the 18th century, St. Paul's continues the tradition of Catholic health care in which all people are cared for with compassion. As leaders of the Saskatoon Health Region's Spiritual Care Program, our Spiritual Care workers assist patients and families of all faiths with their spiritual needs.

Because we also are a teaching facility, our Hospital's commitment to Spiritual Care extends into education and training. Since 1992, we've been offering nationally accredited programs in Clinical Pastoral Education which include instruction, group work and student clinical practice in Saskatoon hospitals. This year, through a partnership with the University of Saskatchewan, Spiritual Care co-sponsored a research project that examined patient-reported outcomes of Spiritual Care Service. The results were presented at the Canadian Association for Spiritual Care and Covenant Health Research Day and will be published soon.

Spiritual Care also continues to focus on further integrating spiritual care throughout Health Region facilities. The Department developed a Smudging Facilitation policy and is seeking approval to transform the fourthfloor Chapel at Royal University Hospital into a multi-faith facility. At St. Paul's Hospital, the First Nations Prayer and Ceremonial Room received new artwork, a ceremonial drum and rattle and renewed four-colours flooring.

#### **Ethics Services**

From the particular perspective of a Catholic health care facility, St. Paul's Hospital has long recognized that patients, families and staff must sometimes make difficult health care decisions that may include conflicts of values. During these times, Ethics Services is available to provide ethics consultation and education support to patients, families and staff.

Significant time was spent this year enhancing the capacity of Ethics Services. The SPH Ethics Committee and the Saskatoon Health Region/Saskatchewan Cancer Agency Joint Ethics Committee collaborated during Ethics Week to provide education for health care workers.

Work on the revising the Health Region's Resuscitation Policy, Resuscitation Care Plan and Serious Illness – Sudden Collapse Plan also continued, which involved extensive consultation throughout the Health Region. The Serious Illness – Sudden Collapse Plan was reviewed and incorporated into the plan to improve continuity of care for patients transferring between acute care and long-term care. Additionally, through a partnership with Mental Health and Addictions Services, work began on a policy to guide the care of individuals with addictions in SHR's acute and long-term care settinas.

St. Paul's Hospital also expanded its Advance Care Directives with the development of a new Advance Directive.

#### **Laboratory Services**

The St. Paul's Laboratory performs testing and specimen analysis for patients within the Health Region as well as referrals from outside the Region. Pathology and Laboratory Medicine supports patient care by providing diagnostic testing in the areas of Anatomical Pathology, Microbiology, Clinical Biochemistry, Clinical Hematology, Transfusion Medicine and Cytogenetics. The technology and equipment in the SPH Laboratory is complex and the knowledge and skills of staff are called upon daily to test and interpret results prior to verification. With 80% of Health Region patients requiring laboratory services, the work of our staff is very important to ensuring the best possible patient care.

This year, the new \$1.4-million Kinsmen Foundation Digital Transmission Electron Microscope (TEM) in the Mosaic Laboratory opened at St. Paul's Hospital. The TEM, the only one in Saskatchewan used for clinical diagnosis, is life-saving technology used to examine tissue samples at a cellular level. The new TEM dramatically reduces wait times for diagnosis and treatment, and also facilitates acute care training and research at St. Paul's.

#### **Emergency Services**

Emergency Services throughout the Saskatoon Health Region are supported by St. Paul's Hospital. In this dynamic, challenging and fast-paced environment, dedicated teams of physicians, nurses and support staff deliver expert care with compassionate regard for not only the physical but also the spiritual and cultural needs of their patients.

This year, several Emergency Servicesassociated initiatives were successfully completed. To ensure the protection of patients, staff and the public from harmful pathogens such as Ebola, a specialized regional isolation room was designated at St. Paul's. Work also began on a regional project to help eliminate errors during patient transfers. As well, the Department worked with MD Ambulance to improve patient flow processes and as a result, ambulance attendant wait times in Emergency have been reduced. Further, a Patient Satisfaction Survey was conducted at St. Paul's and will be conducted at Saskatoon's two other emergency departments to obtain feedback from patients and the public that will provide information that will help us better tailor Emergency Services to meet increasing demand across the region.

#### Medical Imaging and Nuclear Medicine

As technology progresses and imaging techniques become more advanced and less invasive for patients, our highly skilled Medical Imaging and Nuclear Medicine staff and physicians use complex, state-of-the-art equipment to generate extremely detailed images to analyze, identify and treat medical conditions. Procedures performed by these staff and physicians in Saskatoon Health Region include General Radiology (X-Ray), Fluoroscopy, Angiography/Interventional, Computed Tomography (CT), Lithotripsy, Magnetic Resonance Imaging (MRI), Ultrasound and Nuclear Medicine.

This year, St. Paul's Hospital Foundation raised funds for a new SPECT-CT that will benefit patients suffering from cancers, brain tumours and diabetic complications. A first for the Saskatoon Health Region, SPECT-CT combines two forms of diagnostic imaging allowing doctors to pinpoint and assess the location and severity of a suspected illness in just one visit. We look forward to the installation of the SPECT-CT this year.

#### **Renal (Kidney) Services**

St. Paul's Hospital is the provincial leader in the treatment of renal (kidney) diseases, providing specialized services within Saskatoon Health Region as well as to Northern communities.

Since May 1960, when Saskatchewan's first kidney dialysis was performed at St. Paul's, thousands of kidney patients have benefited from Renal Services. Hemodialysis services are provided at the Hospital, in a community setting at the Cameco Community Renal Health Centre at St. Paul's and in satellite units in Lloydminster, North Battleford, Prince Albert and Tisdale. Renal Services also provides training and support for patients to perform their own dialysis via peritoneal dialysis and for those who wish to receive hemodialysis at home through the Home Based Therapies Program.

More than 50% of St. Paul's renal patients are diabetic. These patients are susceptible to complications requiring complex testing that will soon be possible with the Hospital's new SPECT-CT diagnostic imaging scanner that will be installed in 2015.

Disease prevention is also a goal of Renal Services. The Chronic Kidney Disease Outreach Program works with Northern communities to prevent kidney diseases by promoting healthy living. Once diagnosed, patients and their families are taught how a healthy lifestyle and proper diet can help slow the progression of kidney disease and how to manage it. This past year, with funds raised by the Foundation, the program was expanded to reach more communities.

Further, initiatives were undertaken to improve patient flow through Renal Services, to enhance education on kidney disease treatment options and to improve teaching tools and resources to better meet patient needs. Hemodialysis programs across the province are partnering with Saskatchewan Polytechnic to support staff training for hemodialysis. The program will provide training that merges self-study, distance learning and technical training in Regina and Saskatoon.

#### **Chronic Disease Management**

Our interdisciplinary team of experts in Chronic Disease Management assists clients and families as they adjust to living with chronic disease. Programs and services include education sessions, supervised exercise programs, individual counselling, disease management clinics and selfmanagement and stress management workshops.

This past year, one area of focus was on how chronic obstructive pulmonary disease (COPD) patients utilize our Emergency Department. Work is now underway to test how to best provide support in the community to offset and reduce the need for these individuals to revisit Emergency.

#### **Mental Health and Addictions**

Mental Health and Addiction Services provides in-patient acute, residential and outpatient clinical services to individuals living with mental health and/or addiction issues.

The Department is enhancing mental health care in our community by participating in a number of initiatives such as the Saskatoon Hub and Centre of Responsibility (COR) model, which brings together health care professionals, social service workers and other community partners for strategic prevention and reduction of crime. Two Police and Crisis Teams (PACTs) were created that focus on responding immediately to crisis calls received by police and subsequently when appropriate helping individuals find immediate support and services for mental health and addictions issues.

Mental Health and Addictions also is strengthening its group partnership with Primary Health Services, Population and Public Health Services, Client Patient Access Services and Home Care to better support Lighthouse Supported Living residents. Benefits to Lighthouse resulting from this partnership include a stabilization shelter, a mobile outreach van, addictions counselling, personal care support, nursing care, paramedic services and a number of beds. Mental Health and Addictions also works with Whitecap Dakota Primary Health to develop services in that community.





#### Saskatchewan Transplant Program

St. Paul's Hospital is home to the Saskatchewan Transplant Program. Since its inauguration in 1989, the program has facilitated transplants of hundreds of corneas and kidneys, and supports patients who require or have received a heart, lung, combined kidney-pancreas or liver transplant.

There are over 600 organ recipients living in Saskatchewan. Of those, 473 received a kidney transplant. In 2014, 30 Saskatchewan residents received a kidney or kidney-pancreas transplant, and 112 residents received a cornea transplant. There currently are over 600 organ recipients living in Saskatchewan. Of those, 473 received a kidney transplant. This past year, 30 Saskatchewan residents received a kidney or kidney-pancreas transplant.

The "Offer Hope" campaign, which features personal stories of donors and recipients, was launched this year to raise public awareness of the benefits of organ and tissue donation across Saskatchewan. In addition, a regional policy to streamline and standardize the process for donation referrals was implemented. The policy is based on principles of patient and familycentred care to ensure that every patient and family understands, as part of end-oflife care, the right to participate in making an informed decision regarding organ and tissue donation.

#### **Palliative Care Services**

This year marks a special anniversary for palliative care in Saskatchewan as Palliative Care Services celebrates 25 years of providing quality, compassionate end-of-life treatment.

In 1990, St. Paul's developed the province's first Palliative Care Consultation Team, followed that same year by the opening of a 12-bed Regional Palliative Care Unit. Twenty-five years later, the Hospital continues to provide compassionate care to terminally ill patients and their families with the goal of improving the experience of people living with life-threatening illnesses or nearing the end of life.

In Palliative Care, close attention is focused on responding to patients' physical needs and maintaining their dignity, while also ensuring that the emotional, spiritual and cultural needs of patients and their families are met.

In this 25th anniversary year, processes that impact the delivery of holistic patient and family care were reviewed and improved. As well, the bereavement support group, which offers support for people and families coping with grief, was expanded to include two new support groups: the Shades of Grief and Healing Workshop, and Grief Talk. New state-of-the-art beds were purchased for the Palliative Care Unit with the generous support of donors and community partners. These beds provide additional comfort by allowing loved ones to lay next to patients.




## **2014 Foundation Allocations**

## **Our Donors**

Each year, numerous corporations and community groups and hundreds of individuals and families generously give to St. Paul's Hospital.

Our donors often tell us they give to St. Paul's Hospital as a way to thank our physicians, nurses, employees and volunteers for the kind, compassionate care they or a family member received at St. Paul's.

There are many ways donors can support the Hospital. Options include major corporate and individual gifts; matching gifts that inspire others to give; smaller annual gifts; donations given one-time or regularly throughout the year; and gifts and tributes in memory of a loved one. Whatever the size of the gift, our donors' generous spirit of giving helps ensure our Hospital has the very best equipment available to support the expertise of our skilled and dedicated physicians and specialists.

With wonderful support in 2014, this year we were able to purchase new state-of-theart equipment and replace well-worn but much-needed specialized items that make a big difference in the lives of both our patients and the specialists who treat them.

#### Digital Transmission Electron Microscope

St. Paul's Hospital physicians and technologists are now using one of the best diagnostic tools available. The new \$1.4-million Digital Transmission Electron Microscope (TEM), the only one of its kind in Saskatchewan, became operational at St. Paul's Hospital. Housed in our new Mosaic Laboratory that includes the Kinsmen Foundation Electron Microscope Suite, the TEM is life-saving technology used to examine tissue at the cellular level, significantly enhancing patient care and reducing diagnostic wait times. The TEM also is used for teaching and research.

#### SPECT-CT

Funds totalling \$2.4 million were raised for the purchase and installation of a SPECT-CT scanner, the first in Saskatoon Health Region. The SPECT-CT is used primarily for diagnosing, staging and monitoring treatment effects in multiple medical conditions such as prostate cancer and diabetic infections. It combines a nuclear medicine gamma camera with the latest diagnostic CT technology to produce both

physiologic and anatomic images of the body. Installation of the SPECT-CT is expected to be completed in 2015.

#### **Specialized Equipment**

Through the support of individual donors and community partners, new specialized equipment was purchased including new hemodialysis chairs and state-of-the-art beds for use in the Palliative Care Unit that are comfortable, safe and large enough for loved ones to be physically close to patients. New motorized beds in the Intensive Care Unit offer patients greater comfort and gently rotate, enabling patients to breathe and change position more easily. An Otolaryngology Carbon Dioxide Laser for advanced care also was purchased.

#### **Help Us Help You**

The remarkable success of our "Help Us Help You" fund raising campaign was largely a result of tremendous efforts put forth by St. Paul's Hospital physicians Dr. Samson Haimanot, Dr. Chris Thomson, Dr. Chris Wall and Dr. Kylie Kvinlaug, who engaged with patients, families and the public to promote the impact that new state-of-the-art equipment has on patient care at the Hospital. We are grateful to these physicians for taking time out of their busy schedules to support our campaign.

In 2014, funds were raised to purchase a number of pieces of equipment, including an Endoscopic Ultrasound Scope for use in internal medicine, and an Advanced Imaging and Biopsy Ultrasound used by physicians in diagnostic imaging, gastroenterology and therapeutic endoscopy. Both devices provide faster and more accurate diagnoses, thereby reducing treatment wait times.

A Mini C-Arm X-Ray Scanner will speed up diagnosis and treatment times for people with debilitating hand injuries, getting them back to work and back to normal faster. The scanner will also significantly reduce exposure to radiation for patients as well as for the physicians who perform countless plastic, reconstruction and microsurgeries each year.

A Portable Vascular Doppler Ultrasound, used by vascular and endovascular surgeons, is allowing patients with varicose veins to be treated with Radiofrequency Ablation under local anesthetic, resulting in fewer incisions and less pain and scarring. The device is allowing patients to get back to work and back into regular family life sooner.

## Foundation Programs & Services

#### St. Paul's Hospital Foundation Draws

The Foundation Draws is one of our most popular programs. Our Foundation provides \$100,000 annually to be used to purchase items requested by physicians and employees that might otherwise not receive funding, but do much to improve the Hospital experience for our patients, their families and our staff. Physicians and employees enter into a draw to have their request funded, giving them a chance to contribute to lasting, positive change in our Hospital for the benefit of patients and their families. Items typically requested include equipment, furniture, services and programs.

Some of the larger items funded this year included an Emergency Room Bladder Scanner, a cooling tower vacuum pump for the Hospital's Energy Centre and an Acute Response Cart for the Community Dialysis Unit. Smaller items included waiting room chairs and furniture for a number of areas throughout the hospital, a blanket warmer for the Operating Room, a new wheelchair/ IV pole unit, examination lights and even thermometers! Thank you to our dedicated staff who are providing extraordinary care by recognizing the value of these items to our patients.

#### Hospital Employee Educational Development

Because we are an acute care teaching hospital, education and the sharing of

knowledge is a top priority at SPH. The St. Marguerite d'Youville Endowment Fund was established in 1991 with a gift from the St. Paul's Hospital Nurses' Alumni. Now, through effective stewardship of the fund along with subsequent donor contributions, the Foundation supports professional development and learning opportunities for employees at St. Paul's Hospital and Saskatoon Health Region.
