Our foundation provides Will language for the benefit of future gifts to the foundation. Whether you are leaving a general or specific purpose bequest to the foundation we recommend the following Will language be reviewed with your lawyer. Our legal name is St. Paul's Hospital Foundation Inc.

Unrestricted Bequest to St. Paul's Hospital Foundation Inc

I give, devise and bequeath the sum of _____ dollars to the St. Paul's Hospital Foundation Inc in the City of Saskatoon, Saskatchewan. I declare that the receipt of the Treasurer, or other person properly authorized to give receipts, shall be a sufficient discharge to my Executor.

Unrestricted Trust or Endowment Bequest to St. Paul's Hospital Foundation Inc

I give, devise and bequeath the sum of _____ dollars to the St. Paul's Hospital Foundation Inc in the City of Saskatoon, Saskatchewan. Such sum is to be kept invested for a minimum period of ten years from the date of receipt of the gift and to be held as part of its general trust or endowment funds. The income therefrom is to be used for such health care purposes as the Board of Directors shall determine in its absolute discretion. I declare that the receipt of the Treasurer, or other person properly authorized to give receipts, shall be a sufficient discharge of my Executor, who shall not be obliged to see to the application of the said sum.

Unrestricted Residual Bequest to St. Paul's Hospital Foundation Inc

I give, devise and bequeath the rest and residue of my estate to the St. Paul's Hospital Foundation Inc in the City of Saskatoon, Saskatchewan. I declare that the receipt of the Treasurer, or other person properly authorized to give receipts, shall be a sufficient discharge to my Executor, who shall not be obliged to see to the application of the said sum.

Bequest to St. Paul's Hospital Foundation Inc for a Designated Use

I give, devise and bequeath to the St. Paul's Hospital Foundation Inc in the City of Saskatoon, Saskatchewan, the sum of _____ dollars to be kept invested for a minimum of ten years from the date of receipt of the gift and the income from which is to be used for _____. My trustee under this Will shall be under no obligation to see that the trusts herein are carried out and the receipt of the Treasurer of St. Paul's Hospital Foundation Inc. shall be sufficient discharge thereof.

If in the opinion of the Board of Directors of St. Paul's Hospital Foundation Inc (hereinafter in this clause referred to as "The Board") it should become impossible, inadvisable, or impracticable to apply the said fund (principal or income) for the said purposes, or if the Board is of the opinion that part of the said fund (principal or income) is not required for such purposes, The Board shall use the said fund (principal or income) or such part thereof in such a manner as in its discretion may seem to the best advantage of St. Paul's Hospital for other purposes consistent with the spirit and intent of this gift.

Bequest to St. Paul's Hospital Foundation Inc for an already Established Fund

I give, devise and bequeath the sum of _____ dollars to the St. Paul's Hospital Foundation Inc in the City of Saskatoon, Saskatchewan, to the (already established)fund. I declare that the receipt of the Treasurer, or other person properly authorized to give receipts, shall be sufficient discharge to my Executor, who shall not be obliged to see to the application of the said sum.

If in the opinion of the Board of Directors of St. Paul's Hospital Foundation (hereinafter in this clause referred to as "The Board") it should become impossible, inadvisable, or impracticable to apply the said fund (principal or income) for the said purposes, or if the Board is of the opinion that part of the said fund (principal or income) is not required for such purposes, The Board shall use the said fund (principal or income) or such part thereof in such a manner as in its discretion may seem to the best advantage of St. Paul's Hospital for other purposes consistent with the spirit and intention of this gift.

POWER TO VARY PURPOSES

The following clause empowers the Board of Directors to alter or vary the purposes for which the gift is used if altered conditions make it impossible or impracticable to carry out the original purpose.

If in the opinion of the Board of Directors of St. Paul's Hospital Foundation Inc (hereinafter in this clause referred to as "The Board") it should become impossible, inadvisable, or impracticable to apply the said fund (principal or income) for the said purposes, or if the Board is of the opinion that part of the said fund (principal or income) is not required for such purposes, The Board shall use the said fund (principal or income) or such part thereof in such a manner as in its discretion may seem to the best advantage of St. Paul's Hospital for other purposes consistent with the spirit and intent of this gift.
