# St. Paul's Hospital

A community of health, hope and compassion for all.

St. Paul's Hospital (SPH) is a 264-bed acute care teaching and applied research hospital delivering compassionate and holistic care to the people of Saskatoon and Saskatchewan.

SPH is independently owned by Emmanuel Health and was founded by the Grey Nuns over a century ago, in 1907. In 1996, St. Paul's became the first independently affiliated hospital in Canada to manage health services in tandem with a regional authority—in our case, the Saskatoon Health Region.

In late 2017, the Saskatoon Health Region became a part of the larger Saskatchewan Health Authority and continues to partner with St. Paul's Hospital to provide compassionate and holistic care to the people of Saskatchewan.

Alongside the provincial transition to one health authority, Emmanuel Care created one governing board – Emmanuel Health – for its twelve Catholic health care facilities across

Saskatchewan, including St. Paul's Hospital. Emmanuel Health is with you on your journey toward health, healing and a better quality of life.

Nine former St. Paul's Hospital Board members were appointed to the new Emmanuel Health Board, and leadership roles were formed for Emmanuel Health President and CEO Jean Morrison and St. Paul's Hospital Executive Director Karen Barber. The Hospital is now represented by a Local Council that functions as a committee of the Emmanuel Health Board.

# We Walk With You

This year has been filled with opportunity, hope, teamwork and focus.

It is an inspiration and honour to serve in Catholic health care, with Emmanuel Health's Local Council as well as the staff and community of St. Paul's Hospital. Patients and families frequently tell me about the compassionate, high-quality care they receive in our Hospital. No greater tribute could be paid to the legacy of the Grey Nuns who founded St. Paul's, and the Nurses Alumni who trained here.

I so often have been told that St. Paul's Hospital is very important both to our local community and also to the broader community we serve. Over the years many have come to our doors seeking a safe refuge, protection and shelter from the cold, a place to rest weary bodies and souls. When people come to our doors, whether for purely medical or for many other basic human needs, we are reminded of our foundress, St. Marguerite d'Youville, and her care for the most vulnerable in our midst. We are inspired by her legacy, and we help people get the care they need.

Safety is a priority at St. Paul's Hospital. When we think of safety we tend to think in mainly physical terms, but in reality, safety is much larger than that. At St. Paul's Hospital, we have a broad and holistic view of care and of safety. Our embrace extends to include not only physical but also psychological, social, cultural, emotional and spiritual safety, since these are part of the whole and affect one another.

In support of this holistic view of safety in our hospital and community, we have consulted and engaged with community stakeholders to create roundtable meetings led in prayer by a local elder. The meetings include

representatives from the Saskatoon Police Service, our own Hospital Security Services, First Nations and Métis Health, Social Work, Ethics, Mission and Spiritual Care, managers, staff and administration – all working together to improve safety in and around St. Paul's Hospital. Further, we have a team focused on improving the hospital arrival and entry experience, to create a safe and welcoming place for all.

In honoring our commitment to Truth and Reconciliation, we held a flag-raising ceremony, and installed a permanent mural on the main floor with the theme "We Walk Together." This mural recognizes our relationship with First Nations and Métis people, and our promise to continue in respectful relationship as we journey together toward community health and well-being.

The St. Paul's Hospital Nurses Alumni built upon the teachings set forth by St. Marguerite d'Youville and the Grey Nuns when they established the St. Paul's Hospital School of Nursing in 1909. This year, we honoured the example they set through their compassion, vision and initiative by installing a permanent mural that showcases their legacy and accompanies their School of Nursing displays on the 2nd floor.

As we walk with you on a journey of collaboration, reconciliation and relationship, we remember and honour those who went before us, and together build a better future, ever closer to our vision: a community of health, hope and compassion for all.

## Mission Office

Our objective is to recognize, celebrate and strengthen the mission of St. Paul's Hospital: "A community of health, hope and compassion for all." The Mission Office takes the mission statement off the wall and puts it into practice, providing compassionate, respectful, holistic care with collaboration and good stewardship. Our Healing Arts program creates opportunities for patients and families to express themselves and create meaning through visual art, music therapy and literary art. This year we expanded our partnership circles within the Artist-in-Residence, Writer-in-Residence and Music programming to engage additional community partners. Staff and physicians recognize the profound positive benefits of integrating arts into the delivery of health care for patient healing and well-being.

## Ethics Services

In our Catholic facility, ethics is at the forefront of patient care, providing education and resources to help patients, their families and staff. This year, we provided 72 education sessions on topics including ethics orientation, end-of-life care and persons living with addictions. We also participated in 244 ethics consultations with staff, patients and their families. St. Paul's Hospital Ethics Services also partnered with the Saskatchewan Health Authority and other interested parties to create a provincial ethics program that will provide support to patients, families and health care staff across the province.

## Spiritual Care

Our goal is to provide an initial spiritual care visit to each and every patient admitted to St. Paul's Hospital and to continue to offer care to those who need and desire ongoing spiritual support. We are on duty 15 hours a day, every day, all year, and we work alongside other faith traditions to ensure that a hospital stay does not disconnect patients from their communities of spiritual support. This year we have increased visibility in the Emergency Department, so patients know we are there when they really need us most. We are especially proud of the relationships we have

built to help us to make those all-important connections within our community.

### **Kidney Health and Provincial Transplant Services**

St. Paul's Hospital provides hemodialysis and other specialized medical services both in-Hospital and in the community for Saskatoon and the northern regions of the province. The department prides itself on the growth of home-based dialysis, allowing patients to receive the care they need in their own homes. Since 2004 hundreds of kidneys have been transplanted at St. Paul's, and those numbers continue to rise. This year, we collaborated with the Intensive Care Unit to bring improved access to organ donations. While kidney patient volumes continue to increase, the department remains consistent in providing excellent patient care.

### **Diagnostic Imaging and Nuclear Medicine**

The department plays an important role in both diagnosing and preventing the spread of diseases like cancer. This year we were assisted in our work by the generosity of our community who provided donations to support the purchase of a blanket warmer, vein viewer and two patient monitors, enabling staff to provide the highest quality of care and comfort to the patients we serve. We are also grateful to those who donated to our Foundation in support of a Computed Tomography unit, also known as a CT Scanner. We look forward to purchasing the unit and making upgrades to the Medical Imaging Nursing Recovery area in the upcoming year.

### **Laboratory and Pathology Services**

St. Paul's Hospital manages and performs all testing and specimen analysis for Saskatoon and other external referrals in the areas of Pathology, Hematology, Clinical Biochemistry and Transfusion Medicine. Thanks to community gifts to St. Paul's Hospital Foundation, we will be installing a pneumatic tube system of delivering specimens that will allow for faster delivery of laboratory results,

helping us to serve patients' needs more effectively and efficiently.

### **Primary Health and Chronic Disease Management**

We are proud of our collaboration with various groups and individuals in bringing patients the specialized holistic care they need. Last year we contracted a Cultural Advisor to guide and advise us on more culturally responsive programming. We engaged Indigenous Elders and Traditional Knowledge Keepers in sharing traditional indigenous teachings, healing, medicine prayers, storytelling and sharing circles. We initiated a traditional food resource working group to have conversational interviews with Traditional Knowledge Keepers throughout the province to guide the development of an educational resource for families and educators, highlighting Indigenous traditional food practices and promoting wellness through connections to the land, language and culture. We are also happy to report that a nurse practitioner has joined the team to identify and fill gaps in Chronic Obstructive Pulmonary Disease care and to assist clients in avoiding Emergency Department visits.

### **Mental Health and Addiction Services**

We provide inpatient psychiatric care, detox/residential addictions treatment and outpatient clinical services to patients and families living with mental illness and addiction issues. New initiatives for 2018 included significant investments in Child and Youth counselling and psychiatric services to meet the increased demand. We also initiated community recovery teams who provide intensive and interdisciplinary support to those living with complex mental health disorders. We also added additional positions to support the Community Connected Care strategy in core neighbourhoods, coordinating seamless, accessible and connected care for patients regardless of their location in hospitals, homes or other communities.

### Emergency and Air Ambulance Services

Emergency Department physicians, nurses and support staff strive to provide expert care in a compassionate manner that meets the physical, spiritual and cultural needs of patients who require urgent care. We are excited about new community initiatives like the Managed Alcohol Program where we work with community partners to help people get off the streets, support the vulnerable and ensure they have access to appropriate care. A cross-functional approach to dealing with community health issues means we can truly serve our patients in a way that better meets their needs. The Community Paramedicine program continues to expand. Most recently, the program has committed to supporting patients upon discharge including patients in any acute care facilities in Saskatoon and numerous other areas throughout the province.

### Palliative Care and Hospice Services

St. Paul's Hospital is home to Saskatoon's only Palliative Care Unit. Since the opening of the pioneering unit nearly 30 years ago, we have come to appreciate the value and importance of providing access to specific end-of-life care for our community. Working alongside St. Paul's Hospital Foundation on the Close to Home Campaign for Hospice and End-of-life Care gave us the opportunity to vision additional ways in which we can support increased access to end-of-life care in our city. Our goal of establishing our province's first free-standing, residential Hospice along with completing important renovations to our Palliative Care Unit at St. Paul's Hospital are just two of the ways we know will positively impact this area of care for our community.

We are indebted to you—our donors and community volunteers—for without you, there would be no St. Paul's Hospital Foundation.

It's been an exciting time at our Foundation. In 2018, donors like you helped raise \$8.2 million in support of St. Paul's Hospital and the Close to Home Campaign for Hospice and End-of-life Care.

Our work to develop the Close to Home Campaign was met with astounding generosity from our community. Many of you came forward to support the project with significant donations.

pneumatic tube specimen carrier system for our Laboratory, a Labscan 3D Luminex for the Dr. Marc Baltzan HLA Laboratory, a Draeger Pulmovista 500 for Respiratory Therapy and a supine cycle for physiotherapy support in the Intensive Care Unit. As medical advancements emerge and health care costs rise, your generosity becomes increasingly crucial in helping to ensure patients and families have access to the latest advancements in medical technology, state-of-the-art equipment and holistic, compassionate care. Your support also provides our health care workers with research support, education and training. Thank you for all you do for our Hospital and our community.

### Events

#### Fund Raising Events

The 29th annual Mistletoe Charity Ball, sponsored by Nutrien, raised \$171,750 toward upgrading recovery rooms in Diagnostic Imaging and remodeling the family rooms in the Intensive Care Unit. This signature event marks the beginning of the Christmas season each year, and we are indebted to our volunteer Mistletoe Ball Committee for its hard work and dedication to this event for the past 29 years. The 8th annual Gormley Gathering is a third-party event hosted by Rawlco Radio in support of the Leslie and Irene Dubé Urology Centre for Health. This year the event raised \$128,115. Proceeds will provide a physician with a fellowship in advanced urological training and support the annual Urology Symposium for patients, families and health care professionals. Our Foundation hosted the Give and Grow campaign and raised \$99,103 for a much-needed diagnostic imaging CT Scanner. Our Easter Seeds of Hope letter-writing campaign raised \$86,536 to help

purchase of a Point-of-Care Ultrasound, providing physicians with the capacity to perform crucial ultrasound examinations at the patient's bedside. And our Christmas Dove letter raised \$123,048 in support of specialty Versacare beds that will help prevent and heal bedsores, proving compassionate relief for patients.

#### St. Paul's Hospital Draws

The SPH Foundation Draws are one of our Foundation's most popular programs, giving Hospital employees the opportunity to identify and request funding support for equipment, furniture and services that wouldn't otherwise receive it. This year \$125,000 in improvements were made possible through the Draws, including purchases of wheelchairs for units on the 6th and 7th floors, a Vascular Doppler to measure blood flow through veins and an Elite 200 Doppler to measure fetal heart beats for Day Surgery and the Intensive Care Unit, flame detectors for public washrooms and a freezer for the laboratory.

Each year, St. Paul's Hospital Foundation hosts our Donor Appreciation Luncheon to express our heartfelt gratitude to all of our generous donors. ## Campaign Priorities

### **Priority 1 - Building the Hospice at Glengarda**

*St. Paul's Hospital already owns the perfect building at 301 Hilliard Street which will be expanded, renovated and furnished to become the Hospice at Glengarda – a 15-bed residential hospice providing comfort, peace and tranquility in an environment that is as close to home as possible.*

### **Priority 2 - Holistic Care Endowments**

*Holistic health care changes the lives of patients and their families and is a critical element in the end-of-life process. Two holistic care endowments will be created to provide bereavement care, spiritual care and healing arts therapy to patients and families facing end-of-life, both in the Hospice at Glengarda and in the community.*

### **Priority 3 - Education Fund**

*An end-of-life Education Fund will provide specific, ongoing end-of-life care education so end-of-life care practitioners in our health care system feel empowered and educated to offer the best possible care.*

### **Priority 4 - Palliative Care Unit Renovations**

*Renovations will improve patient experiences and care delivery in the Palliative Care Unit at St. Paul's Hospital. Opened in 1991, the Palliative Care Unit supports acute-care patients and families as they face end-of-life. Even with a new hospice, the demand for in-hospital complex symptom management will remain high.*
